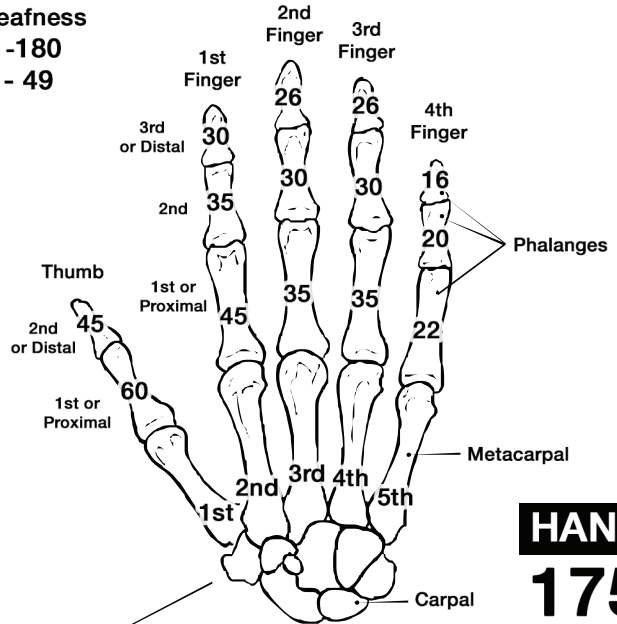
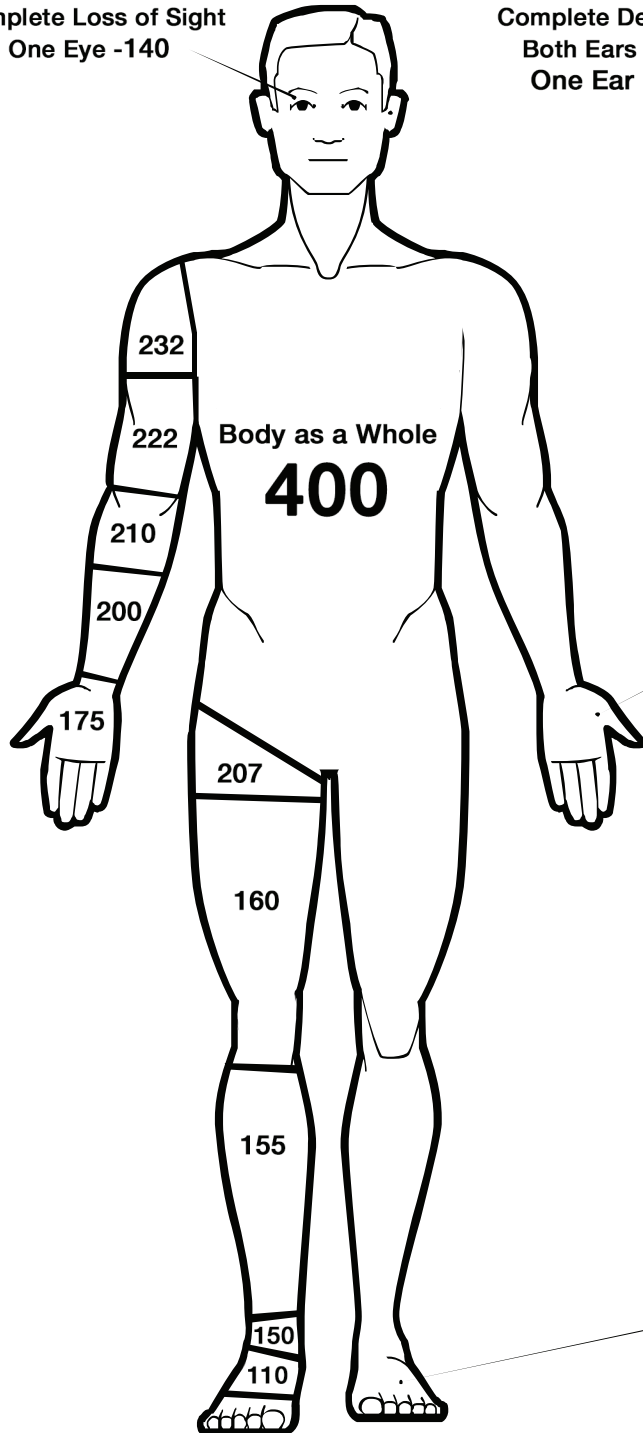


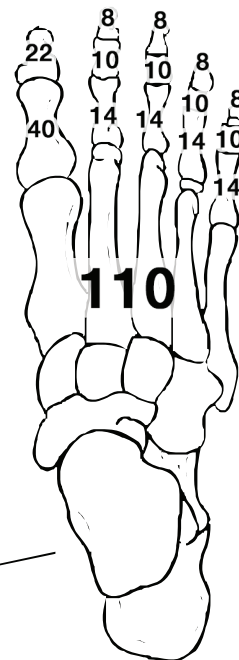

PRE-EXISTING IMPAIRMENT	Credit is allowed for pre-existing PPD.
TEMPORARY TOTAL DISABILITY	Begins after claimant has missed three days during which employer is open for business. If claimant is off 14 days, then employer must pay TTD benefits for the three day waiting period.
DISFIGUREMENT	Maximum 40 weeks to the head, neck, hands or arms.
