CALCULATION OF AVERAGE WEEKLY WAGE

Continuous employment include wage earned for same employer over 26 weeks preceding injury; include overtime hours at the straight time rate.

Weeks with abnormally low earnings should be excluded.

Seasonal employment: One fiftieth of total wages earned from all occupations over year preceding accident. This is a general guideline only; we recommend consultation with attorney to discuss specific fact situations.
